Gift Aid is a simple way for Whitby & District Community Transport to increase the value of your Annual Passenger User fee and any donations that we receive.

### How does Gift Aid work?

If you pay tax you can Gift Aid your Annual Passenger User fee or any donations which means that your £10.00 fee will be worth an extra £2.50 to us. If you complete a Self-Assessment Tax Return, you can also nominate Whitby & District Community Transport to receive all or part of any tax repayment due to you. For further information, please contact us.

Gift Aid enables us to claim back 25p for every £1 you give us. All we need from you is permission to reclaim the tax you have paid to HMRC. You can do this by completing the form below and ticking the box.
